Ritsumeikan University Tuition Reduction Scholarship for International Students Regulations

The English text provided below is for convenience only. English expressions do not change the Japanese content, so in the case of any discrepancy, the original, Japanese version shall be held to be accurate.

Proposed Revision

Ritsumeikan University Tuition Reduction Scholarship for International Students Regulations

January 18, 2017 Revision Regulation No. 864

(Intent)

Article 1 These Regulations are intended to reduce the tuition for international students with superior grades for the purpose of relieving such students' financial burden in accordance with Article 65-2, Paragraph 2 of Ritsumeikan University Regulations and Article 87, Paragraph 2 of Ritsumeikan University Graduate School Regulations and provide for the handling thereof.

(Classifications and Amount of Reduction)

Article 2 The tuition for undergraduate students, as categorized below, will be reduced as follows:

- Undergraduate Students Category I: 100% of tuition during the reduction period; Undergraduate Students Category II: 50% of tuition during the reduction period; Undergraduate Students Category III: 20% of tuition during the reduction period.

- The tuition for graduate students, as categorized below, will be reduced as follows: Graduate Students Category I: 100% of tuition during the reduction period; Graduate Students Category II: 20% of tuition during the reduction period.
- The entrance fee or the tuition for government-financed international students, international students admitted under the Government Graduate Student Overseas Study Program" by the People's Republic of China, international students admitted under the Dual Undergraduate Degree Program, international students admitted under the Linkage Master's Program based on the Professional Human Resource Development Project Phase IV (PHRD-IV) (hereinafter referred to as the "Indonesia Linkage Master's Program"), or international students under an agreement, etc., between universities will also be reduced.

(Students Eligible for Tuition Reduction)

Article 3 Students at Ritsumeikan University, who have acquired or are expected to acquire the "college student" status of residence as stipulated in "the Immigration Control and Refugee Recognition Act," will be eligible for the tuition reduction.

2 Notwithstanding the provisions of the preceding Paragraph, students whose tuition is paid by the Japan International Cooperation Agency, the Asian Development Bank, or any other organization will not be eligible for this tuition reduction

(Number of Recipients)

Article 4 With regard to the maximum number of undergraduate student recipients in their first year, the total in Undergraduate Students Category I and Undergraduate Students Category II shall be specified in Table 1 and the total in Undergraduate Students Category III shall be specified in Table 2, according to the entrance examination procedures.

- With regard to the maximum number of undergraduate student recipients in their second year or later, the total in Undergraduate Students Category I and Undergraduate Students Category II shall be specified in Table 3 and the total in Undergraduate Students Category III shall be specified in Table 4, according to the entrance examination procedures.
- 3 The maximum number of Graduate Students Category I and Graduate Students Category II recipients in their first year shall be specified in Table 5.
- 4 The number of Graduate Students Category II recipients in their second year or later shall be the same as the number of applicants thereof.

(Reduction Period)

Article 5 The duration of the tuition reduction is as follows:

- Undergraduate students in their first year: two consecutive semesters following enrollment; Undergraduate students in their second year or later or Graduate Students Category II recipients, who entered in April: the spring semester and the fall semester immediately following;
- (3) Undergraduate students in their second year or later or Graduate Students Category II recipients, who entered in September: the fall semester and the spring semester immediately following;
- (4) Graduate Students Category I recipients: the standard number of years for program completion.
- 2 Notwithstanding the provisions of the preceding Paragraph, the duration of the tuition reduction for students who return to school after a leave of absence (excluding recipients under Graduate Students Category I) is as follows:

Students who entered in April and returned to school in the fall semester: the fall semester in which they returned; Students who entered in September and returned to school in the spring semester: the spring semester in which they returned.

(Application)

Article 6 Students who wish to receive the tuition reduction must submit the designated forms to the Executive Director of the Division of International Affairs by the specified date.

- 2 With regard to the tuition reduction for undergraduate students, students who wish to receive the tuition reduction for their first year may only apply at the time of application for the entrance examination; students who entered in April and wish to receive the tuition reduction for their second year or later may only apply in April of each year; and students who entered in September and wish to receive the tuition reduction for their second year or later may only apply in October of each year.
- 3 With regard to the tuition reduction for graduate students, students who wish to receive the Graduate Students Category I tuition reduction may only apply at the time of enrollment following the announcement of the entrance examination results; students who entered in April and wish to receive the Graduate Students Category II tuition reduction may only apply in April of each year; and students who entered in September and wish to receive the Graduate Students Category II tuition reduction may only apply in October of each year.
- Notwithstanding the provisions of the preceding two paragraphs, students referred to in Article 5, Paragraph 2.1, who wish to receive the tuition reduction may only apply in October of each year and students referred to in Article 5, Paragraph 2.2, who wish to receive the tuition reduction may only apply in April of each year.

(Application Eligibility Requirements)

Article 7 To be eligible to apply for the undergraduate tuition reduction for their first year, applicants must take any of the following entrance examinations:

- Entrance examination for international students (spring semester/fall semester);
- Entrance examination with recommendation for international students (Japanese language schools);
- Study abroad entrance examination with recommendation (phase I/phase II);
- AO (admission office) entrance examination (English basis)
- Entrance examination with recommendation (English basis).
- 2 To be eligible to apply for the undergraduate tuition reduction in their second year or later, applicants must meet any of the following criteria; provided, however, that if a student transferred or moved in (hereinafter referred to as "Transfer, etc.") to Ritsumeikan University in their second year or later, and applies for the tuition reduction for the year in which they Transferred, etc., then the applicant must meet

all of the following criteria:

- (1) earned 10 or more total credits in the two semesters immediately preceding the semester in which an application is made (hereinafter referred to as "Standard Number of Credits.");
- (2) earned 1/8 or more of the number of credits required for graduation multiplied by the number of semesters completed, up until the end of the semester immediately preceding the semester in which an application is made.
- 3 To be eligible to apply for the Graduate Students Category I tuition reduction, applicants must take the entrance examination specified in the entrance examination procedures of each graduate course.
- 4 To be eligible to apply for the Graduate Students Category II tuition reduction, applicants must not be Graduate Students Category I recipients.

(Application Limit)

Article 8 Students who have received a tuition reduction may apply again after their reduction period ends; provided, however, that they may not apply for the tuition reduction for the period cumulatively.

2 If applying for the tuition reduction two or more times, undergraduate students may only apply through the end of their program duration stipulated in Article 17 of the Ritsumeikan University Regulations, and graduate students may only apply until the end of their standard program duration, with the exception of an absence period.

(Selection and Determination)

Article 9 Tuition reduction recipients (hereinafter, referred to as "Recipients") and reduction categories shall be determined by the Executive Director of the Division of International Affairs based on the selection at the International Center Conference.

(Selection Method)

Article 10 The selection of undergraduate students who wish to receive the tuition reduction for their first year will be made following the entrance examinations referred to in Article 7, Paragraph 1 and they will be divided into Undergraduate Students Category I, Undergraduate Students Category III, based on entrance examination scores.

The selection of undergraduate students who wish to receive the tuition reduction for their second year or later will be made in the following order:

Undergraduate Students Category I

Students who have earned the Standard Number of Credits or more until the end of the semester immediately preceding the semester in which an application is made, and whose grades in these earned credits rank the highest;

Undergraduate Students Category II Students who have earned the Standard Number of Credits or more until the end of the semester immediately preceding the semester in which an application is made, and whose grades in these earned credits rank the highest among the next tier below Undergraduate Students Category I;

(3) Undergraduate Students Category III

Students who have acquired 10 or more total credits in the two semesters immediately preceding the semester in which an application is made, and whose grades in these earned credits rank the highest among the next tier below Undergraduate Students Category II.

- The selection of undergraduate students in their first year referred to in Article 5, Paragraph 2 will be made separately from the selection referred to in Paragraph 1 and they will be divided into Undergraduate Students Category I, Undergraduate Students Category II, and Undergraduate Students Category III, based on entrance examination scores.
- 4 The selection of undergraduate students in their second year or later referred to in Article 5, Paragraph 2 will be made separately from the selection referred to in Paragraph 2, and students who have earned credits corresponding to the Standard Number of Credits until the end of the semester immediately preceding the semester in which they took a leave of absence from studies will be divided into Undergraduate Students Category I, Undergraduate Students Category II, and Undergraduate Students Category III, based on a ranking of their grades in their credits earned.
- 5 If students, who Transferred, etc. to Ritsumeikan University, apply for the tuition reduction for the year in which they Transferred, etc., "grades in their credits earned" referred to in the preceding Paragraph shall refer to grades calculated by converting credits earned prior to the enrollment into grading B.
- 6 The selection of Graduate Students Category I Recipients will be made based on entrance examination scores.
- There is no selection process for Graduate Students Category II Recipients and all eligible students who have applied will receive the tuition reduction.

(Revocation of Receipt)

Article 11 Upon the occurrence of any of the following events on the part of Recipients, the Executive Director of the Division of International Affairs will revoke their tuition reduction for the semester in which such event occurred and beyond

Deliberate falsification or forgery of the application documents;

Being no longer eligible for the tuition reduction referred to in Article 3;

Taking a leave of absence from studies;

Withdrawal or expulsion from the University; Receipt of disciplinary suspension for three months or more; or

- Other events determined by the Executive Director of the Division of International Affairs to be unbefitting of Recipients.
- 2 The provisions of Paragraph 1.3 shall not apply to Graduate Students Category I Recipients.

(Suspension of Receipt)

Article 12 Upon the occurrence of any of the following events on the part of Graduate Students Category I Recipients, the Executive Director of the Division of International Affairs will suspend their tuition reduction for the semester in which such event occurred

- Taking a leave of absence from studies;
 Other events deemed by the Executive Director of the Division of International Affairs to warrant the suspension of tuition reduction.
- 2 If the events referred to in the preceding Paragraph no longer apply, Recipients may receive the tuition reduction again.

(Repayment)

Article 13 Students whose receipt of the tuition reduction is revoked in accordance with Article 11 must pay tuition equal to the amount of reduction for the corresponding semester(s). In this case, students must pay the tuition all at once, within two weeks from the date of receipt of the notice of revocation

(Special Provisions for Government-financed International Students)

Article 14 Notwithstanding the provisions of Articles 3 through 13, government-financed international students who are admitted by the recommendation stipulated in Article 4, Paragraph 2 of the Implementation Guidelines for Government-financed International Students Program will receive the reduction of all of the entrance fee and the tuition in accordance with this Article.

- 2 The tuition reduction period shall be the semester(s) that the Ministry of Education, Culture, Sports, Science and Technology selects for government-financed international students.
- 3 If students, who received the reduction of all of the entrance fee and the tuition in accordance with Paragraph 1, are subject to any of the events referred to in Article 11, Paragraph 1, or are no longer government financed international students, the Executive Director of the Division of International Affairs will revoke their reduction. In this case, the provisions of Article 13 shall apply.

(Special Provisions for International Graduate Students Dispatched by Chinese Government)

- Article 15 Notwithstanding the provisions of Articles 3 through 13, international students who are admitted under the "Chinese Government Graduate Student Overseas Study Program" by the People's Republic of China will receive the reduction of all of the entrance fee and the tuition in accordance with this Article.
- 2 The tuition reduction period shall be three years; provided, however, that if it is deemed that the period of attendance at the University should be extended, the period of the tuition reduction shall be specified by the University.
- 3 If students, who received the reduction of all of the entrance fee and the tuition in accordance with Paragraph 1, are subject to any of the events referred to in Article 11, Paragraph 1, the Executive Director of the Division of International Affairs will revoke their reduction. In this case, the provisions of Article 13 shall apply.

(Special Provisions for International Students Admitted under Indonesia Linkage Master's Program)

Article 16 Notwithstanding the provisions of Articles 3 through 13, international students who are admitted under the Indonesia Linkage Master's Program will have their entrance fee and tuition reduced by the amount paid by the Indonesian government, in accordance with this Article.

- 2 The tuition reduction period shall be one year.
- 3 If students, who received the entrance fee and tuition reductions in accordance with Paragraph 1, are subject to any of the events referred to in Article 11, Paragraph 1, the Executive Director of the Division of International Affairs will revoke their reduction. In this case, the provisions of Article 13 shall apply.

(Special Provisions for International Students Admitted under Dual Undergraduate Degree Program)

Article 17 Notwithstanding the provisions of Articles 3 through 13, international students who are admitted under a Dual Undergraduate Degree Program with foreign universities, etc., that have a tuition reduction agreement with the University, will receive this tuition reduction in accordance with this Article.

- 2 The tuition reduction period shall be two semesters from the date of admission; provided, however, that if it is deemed that the period of the tuition reduction should be extended, it may be extended for up to another four semesters.
- 3 The amount of the tuition reduction shall be as specified in Table 6-1 and Table 6-2.
- 4 In the case of the provisory clause in Paragraph 2, beginning with the third semester following the date of admission, a review of the tuition reduction extension for each semester shall be made at the start of the semester.
- 5 If students do not pass the review for the extension referred to in the preceding Paragraph, they will not receive the tuition reduction for that semester.
- 6 The requirement for the extension is that students must have a 3.0 GPA from the date of admission until the end of the preceding semester.
- 7 If students, who received the tuition reduction in accordance with Paragraph 1, are subject to any of the events referred to in Article 11, Paragraph 1, the Executive Director of the Division of International Affairs will revoke their reduction. In this case, the provisions of Article 13 shall apply.

(Special Provisions for International Students Admitted under Agreement, etc. between Universities)

Article 18 Notwithstanding the provisions of Articles 3 through 13, international students who are admitted under an agreement with foreign universities, etc. that determines the tuition reduction received will receive the reduction in accordance with this Article.

- 2 The tuition reduction period shall be as stipulated in the agreement.
- 3 The amount of the tuition reduction shall be as stipulated in the agreement.
- 4 If students, who received the tuition reduction in accordance with Paragraph 1, are subject to any of the events referred to in Article 11, Paragraph 1, the Executive Director of the Division of International Affairs will revoke their reduction. In this case, the provisions of Article 13 shall apply.

(Improvement or Removal)

Article 19 The Board of Executive Directors shall make an improvement to and/or elimination of these Regulations.

Supplementary Provisions (October 12, 2016—Full Revision upon Implementation of Tuition Reduction Program in or after the 2017 Fiscal Year)

These Regulations shall come into force on April 1, 2017.

- 2 Notwithstanding the provisions of the preceding Paragraph, with regard to students for whom the receipt of the tuition reduction has been decided prior to March 31, 2017, the provisions then in force shall remain applicable.
- 3 Upon enforcement of these Regulations, the Ritsumeikan University Special Encouragement Scholarship (Tuition Reduction Scheme) for Privately Financed International Students Regulations shall be abolished, provided, however, that with regard to students for whom the receipt of the tuition reduction has been decided prior to March 31, 2017, the provisions then in force shall remain applicable.

Supplementary Provisions (January 18, 2017-Partial Revision: Change of the Regulations' title.)

These Regulations shall come into force on April 1, 2017.

(趣旨)

(種別および減免額)

- 第2条 学部学生の授業料の減免は、次の各号の区分により、当該各号に定める額とする。
- (1) 学部生 I 種 減免学期の授業料の 100%の額
- (2) 学部生Ⅱ種 減免学期の授業料の50%の額
- (3) 学部生Ⅲ種 減免学期の授業料の20%の額
- 2 大学院学生の授業料の減免は、次の各号の区分により、当該各号に定める額とする。
- (1) 院生 I 種 減免学期の授業料の 100%の額
- (2) 院生Ⅱ種 減免学期の授業料の 20%の額
- 3 前項のほか、国費外国人留学生、中華人民共和国「国家建設高水平大学公派研究生項目」により受入れる外国人留学生、学部共同学位プログラ ム受入留学生、第 IV 期高等人材開発 (PHRD-IV) によるリンケージ修士課程プログラム (以下「インドネシアリンケージ修士学位プログラム」という。)、または大学間協定等にもとづく留学生に対し、入学金または授業料の減免を行う。

(減免の対象者)

- 第3条 授業料減免の対象者は、本大学に在学する者で「出入国管理及び難民認定法」に定める「留学」の在留資格を有するものまたは取得見込み のものとする。
- 2 前項にかかわらず、本人に代わり独立行政法人国際協力機構、アジア開発銀行その他の機関が授業料の納入をしている者は、本減免の対象とし ない。

(適用人数)

- 第4条 1年次の学部学生に対する適用人数の上限は、学部生Ⅰ種および学部生Ⅱ種にあっては別表1、学部生Ⅲ種にあっては入学試験の方式に応 じて別表2のとおりとする。
- 2 2 年次以降の学部学生に対する適用人数の上限は、学部生Ⅰ種および学部生Ⅱ種にあっては別表3、学部生Ⅲ種にあっては入学試験の方式に応 じて別表4のとおりとする。
- 3 1年次の大学院学生に対する院生 Ⅰ種および院生 Ⅱ種の適用人数の上限は、別表 5 のとおりとする。
- 4 2年次以降の大学院学生に対する院生Ⅱ種の適用人数は、申請者数と同数とする。

(減免の期間)

- 第5条 授業料を減免する期間は、次の各号に定めるとおりとする。
- (1) 1年次の学部学生 入学時から連続して2学期間
- (2) 2年次以降の学部学生または院生Ⅱ種の適用者のうち4月に入学した者 春学期および引き続く秋学期の2学期間
- 2年次以降の学部学生または院生Ⅱ種の適用者のうち9月に入学した者 秋学期および引き続く春学期の2学期間 (3)
- (4) 院生 I 種の適用者 入学時から標準修業年限までの各学期間
- 2 前項にかかわらず、休学し、復学した者(院生 I 種の適用者を除く。)で次の各号に定めるものについて、授業料を減免する期間は次のとおりと する。
- (1) 4月に入学した者で秋学期に復学した者 復学した秋学期間 (2) 9月に入学した者で春学期に復学した者 復学した春学期間

(申請)

- 第6条 授業料の減免を希望する者は、指定の日までに所定の書類を国際部長に提出しなければならない。
- 2 学部学生に対する授業料の減免は、1年次における減免の適用を希望する者にあっては入学試験の出願時に、2年次以降の者にあっては4月に 入学した者は毎年4月に、9月に入学した者は毎年10月に、申請を受け付ける。
- 3 大学院学生に対する授業料の減免は、院生Ⅰ種にあっては入学試験の合格発表後の入学手続時に、院生Ⅱ種にあっては4月に入学した者は毎年 4月に、9月に入学した者は毎年10月に、申請を受け付ける。
- 前2項にかかわらず、前条第2項第1号に定める者にあっては毎年10月に、同項第2号に定める者にあっては毎年4月に、申請を受け付け る。

(申請資格)

- 第7条 学部の1年次における減免を申請できる者は、次のいずれかの入学試験の受験者とする。
- (1) 外国人留学生入学試験(前期実施・後期実施)
- (2) 外国人留学生推薦入学試験(日本語学校)
- (3) 海外推薦入学試験 (Ⅰ期·Ⅱ期)
- (4) AO 英語基準入学試験
- (5) 推薦英語基準入学試験
- 2 学部の2年次以降の減免を申請できる者は、次の各号のいずれかを満たす者とする。ただし、2年次以降に編入学または転入学(以下「編入学等」という。)した者が編入学等した年次に減免の申請をする場合については、次の各号のすべてを満たすものとみなす。
- (1) 申請日の属する学期の直前の2学期の修得単位数の合計が10単位以上であること。
- 申請日の属する学期の直前学期までの修得単位数の合計が、卒業に必要な単位数の8分の1に申請日の属する学期までに在学した学期数を乗 じた単位数 (以下「標準単位数」という。) 以上であること。
- 3 院生 I 種の減免を申請できる者は、研究科ごとに入試要項で指定する入学試験の受験者とする。

4 院生Ⅱ種の減免を申請できる者は、院生Ⅰ種を適用されていない者とする。

(申請の制限)

- 第8条 過去にこの減免の適用を受けた者が、再び減免の申請を行うことを妨げない。ただし、減免の学期が重複する申請はできない。
- 2 複数回の減免の申請を行う場合において、通算した減免の期間は、学部学生にあっては学則第 17 条に定める修業年限までの学期間を、大学院 学生にあっては標準修業年限までの学期間を上限とする。ただし、休学期間を除く。

(選考および決定)

第9条 授業料減免の適用者(以下「適用者」という。) および適用する種別は、国際教育センター合同会議において選考し、国際部長が決定のう え通知する。

(選考方法)

- 第10条 学部学生の1年次において減免の適用を希望する者に対する選考は、第7条第1項に定める入学試験ごとに行い、入学試験の得点の高い者から学部生I種、学部生Ⅱ種、学部生Ⅲ種の順に割り当てる方法による。
- 2 学部学生の2年次以降の者に対する選考は、次の各号の順に割り当てる方法による。
- (1) 学部生 I 種

申請日の属する学期の直前学期までの修得単位数の合計が標準単位数以上である者のうち、修得済み単位の成績の上位者

- (2) 学部生Ⅱ種
 - 申請日の属する学期の直前学期までの修得単位数の合計が標準単位数以上である者のうち、修得済み単位の成績が前号に次ぐ者
- (3) 学部生Ⅲ種
 - 申請日の属する学期の直前の2学期の修得単位数の合計が10単位以上である者のうち、修得済み単位の成績が第1号および第2号に次ぐ者
- 3 1年次の学部学生で第5条第2項に定める者に対する選考は、第1項の選考とは別に行い、入学試験の得点の高い者から学部生Ⅰ種、学部生Ⅱ 種、学部生Ⅲ種の順に割り当てる方法による。
- 4 2年次以降の学部学生で第5条第2項に定める者に対する選考は、第2項の選考とは別に行い、休学する直前学期までの修得単位数の合計が標準単位数以上である者について、修得済み単位の成績の上位者から学部生Ⅰ種、学部生Ⅱ種、学部生Ⅲ種の順に割り当てる方法による。
- 5 編入学等した者が編入学等した年度に減免の申請をする場合においては、前項各号に定める「修得済み単位の成績」は、入学前に修得した単位 をB評価として換算した成績をいうものとする。
- 6 院生 I 種の選考は、入学試験の得点により行い、得点の高い者から適用する。
- 7 院生Ⅱ種の選考は行わず、申請した対象者全員に適用する。

(適用の取消し)

- 第11条 授業料減免の適用者が、次の各号の事由のいずれかに該当するときは、国際部長は、当該事由の発生日が属する学期およびそれ以降の学期の減免の適用を取り消す。
- (1) 申請書類への虚偽の記載等の不正を行ったとき。
- (2) 第3条に定める対象者でなくなったとき。
- (3) 休学したとき。
- (4) 退学または除籍となったとき。
- (5) 3か月を超える停学処分を受けたとき。
- (6) その他国際部長が授業料減免の適用者としてふさわしくないと判断したとき。
- 2 前項第3号は、院生I種の適用者については適用しない。

(適用の休止)

- 第12条 院生I種の適用者が、次の各号の事由のいずれかに該当するときは、国際部長は、当該事由の発生日が属する学期の減免を休止する。
- (1) 休学したとき
- (2) その他国際部長が授業料減免の適用を休止することが相当であると認めたとき。
- 2 前項の事由がなくなったときは、授業料減免の適用を再開する。

(納入)

第13条 第11条により、授業料減免の適用を取り消された者は、当該学期の減免額に相当する授業料の納入をしなければならない。この場合に おいては、取消しの通知を受けた日から起算して2週間以内に一括して納入しなければならない。

(国費外国人留学生の特例)

- 第14条 第3条から前条までの定めにかかわらず、国費外国人留学生制度実施要領第4条第2項に定める推薦方法により受入れる国費外国人留学生は、本条の定めるところにより入学金および授業料の全額を減免する。
- 2 授業料の減免の期間は、文部科学省の国費外国人留学生に採用されている学期とする。
- 3 国際部長は、第1項により入学金および授業料の減免をされた者が、第11条第1項各号に定める事由に該当するときまたは国費外国人留学生でなくなったときは、その者に対する減免の適用を取り消す。この場合においては、第13条を準用する。

(中国政府大学院留学生の特例)

- 第15条 第3条から第13条までの定めにかかわらず、中華人民共和国「国家建設高水平大学公派研究生項目」により受入れる外国人留学生は、本条の定めるところにより入学金および授業料の全額を減免する。
- 2 授業料の減免の期間は、3年間とする。ただし、在学期間の延長を認めた場合は、本大学の定める期間とする。
- 3 国際部長は、第1項により入学金および授業料の減免をされた者が、第11条第1項各号に定める事由に該当するときは、その者に対する減免の適用を取り消す。この場合においては、第13条を準用する。

(リンケージ修士学位プログラムの特例)

- 第16条 第3条から第13条までの定めにかかわらず、インドネシアリンケージ修士学位プログラムにより受入れる外国人留学生は、本条の定めるところにより入学金および授業料のうちインドネシア政府が支払った額を差し引いた残額について減免する。
- 2 授業料の減免の期間は、1年間とする。
- 3 国際部長は、第1項により入学金および授業料の減免をされた者が、第11条第1項各号に定める事由に該当するときは、その者に対する減免の適用を取り消す。この場合においては、第13条を準用する。

(学部共同学位プログラム受入留学生の特例)

- 第17条 第3条から第13条までの定めにかかわらず、学部共同学位プログラムに関する海外の大学等との協定において授業料減免の定めがある 大学より受入れる外国人留学生は、本条の定めるところにより授業料を減免する。
- 2 授業料の減免の期間は、受入日から2学期間とする。ただし、継続を認める場合は、1学期間を単位とし4学期間を上限とする。
- 3 減免する授業料の額は、別表6-1および別表6-2に定める。
- 4 第2号ただし書の場合においては、受入れの日から3学期目以降は毎学期の開始に、当該学期の減免について継続審査を行う。
- 5 前項の継続審査に合格しないときは、その学期の減免を行わない。
- 6 継続の要件は、受入れの日から前学期までの GPA が、通算して 3.0 以上とする。
- 7 国際部長は、第1項により授業料の減免をされた者が、第11条第1項各号に定める事由に該当するときは、その者に対する減免の適用を取り消す。この場合においては、第13条を準用する。

(大学間協定等にもとづく留学生の特例)

- 第 18条 第 3条から第 13条までの定めにかかわらず、留学生受入れに関する海外の大学等との授業料減免の定めがある協定にもとづき受入れる 外国人留学生は、本条の定めるところにより授業料を減免する。
- 2 授業料の減免の期間は、協定に定める期間とする。
- 3 減免する授業料の額は、協定に定める額とする。
- 4 国際部長は、第1項により授業料の減免をされた者が、第11条第1項各号に定める事由に該当するときは、その者に対する減免の適用を取り消す。この場合においては、第13条を準用する。

(改廃)

第19条 この規程の改廃は、常任理事会が行う。

附則 (2016 年 10 月 12 日 2017 年度以降の授業料減免制度の実施等に伴う全部改正) この規程は、2017 年 4 月 1 日から施行する。

- 2 前項にかかわらず、2017年3月31日までに授業料減免の適用が決定した者については、なお従前の例による。
- 3 この規程の施行に伴い、立命館大学私費外国人留学生特別奨励生授業料減免規程を廃止する。ただし、2017年3月31日までに同規程にもとづき授業料減免の適用が決定した者については、なお従前の例による。

附則 (2017年1月18日 規程名称の変更に伴う一部改正) この規程は、2017年4月1日から施行する。

附 則(2018年1月17日 学期名称の変更に伴う一部改正) この規程は、2018年4月1日から施行する。
