International Seminar: "Japan-ROK (ROK-Japan) Economic S ecurity Dialogue" Co-hosted with KIEP

On Sunday, December 8, 2024, the Center for East Asian Peace and Cooperation Studies at Ritsumeikan University, in collaboration with the Korea Institute for International Economic Policy (KIEP), hosted the international seminar "Japan-ROK (ROK-Japan) Economic Se curity Dialogue."
