#### 1. Application Eligibility

1-1	Can I apply if I exceed the minimum standard program duration for my degree program? (e.g. year 5 or greater for undergrads, year 7 or greater for pharmacy undergrads)	Undergraduate and graduate students alike are eligible to apply even if they exceed their minimum standard program duration.
1-2	Can I apply if my student status is "leave of absence" or "studying abroad"?	Yes, you are eligible to apply.
1-3	Can I apply if I am a non-degree student or a non-regular student?	This subsidy is for regular undergraduate and graduate students currently enrolled at the university. Unfortunately, you are not eligible to apply.
1-4	I am a foreign national (not holding Japanese citizenship) with a status of residence. Are there any limitations for applying based on status of residence?	There are no limitations based on status of residence.
1-5	Can I apply if I am currently living in a university dorm?	Yes, you are eligible to apply.
1-6	I'm an international student. Can I apply?	Please see section 6. "Applying as an International Student."

2-6	My financial supporter's (my parents') income has decreased. Should I include an attachment attesting to this fact?	Because we will not be looking at financial supporters' (parents') income, attaching such documents is unnecessary. If your parents' income decreased, and as a result your allowance significantly decreased, please attach a document attesting to this fact.
2-7	Due to the spread of COVID-19, my financial situation became very difficult and I had no choice but to withdraw from school. I would like to return to school, but I have no money and would like to apply for the subsidy. Can I apply?	We are very sorry, but only students registered in the regular curriculum are covered by this support fund, so you are not eligible to apply.
2-8	My allowance, not from my parents, but from a financial supporter has decreased significantly. Can I apply?	Yes, you are eligible to apply. Please attach a document attesting to your receiving an allowance from a financial supporter.
2-9	Monthly wages from my part-time job are paid the following month. In other words, in July I'm paid for work I did in June. The application guidelines ask for proof of income from one month of my choosing out of April, May or June: If I were to choose June, should I provide proof of the amount of wages I received in June or July?	Please provide proof of wages earned for services rendered in June.  • If you are paid in June for the hours you worked in June, provide proof of the wages you received in June  • If you are paid in July for the hours you worked in June, provide proof of the wages you recieved in July  *In the case of the latter, if your June payslip won't be ready by the application deadline for this subsidy, please attach proof of income for either April or May instead.
2-10	I have a part-time employment contract with the Ritsumeikan Trust (for work as a TA/ES/etc). What kind of certificate should I submit as proof of a decrease in income?	Please submit a scan or image of a payslip, the pages of your bankbook showing your part-time work income, an email from your employer, or any other certificate which proves a decrease in your income.  (Please see section 5.(2)1) of the application guidelines)

# 3. Selection Criteria

3-1	Is academic performance taken into consideration as part of the selection process?	No.
3-2	The application guidelines' selection criteria are not clear. How are applicants chosen?	The university will establish standards based on the amount of decrease/loss of income or allowance of applicants', as well as the level of continuous financial distress reported by applicants, and select applicants based on those standards. Beyond this we cannot answer inquiries into the screening process.
3-3	Will there be quotas for different categories of students (undergraduate, graduate, international, etc.) receiving the subsidy? Students in the College of Film Studies and College of Sciences have very high tuition, so it is very fiscally demanding. Are the criteria the same for these students?	The university will establish standards based on the amount of decrease/loss of income or allowance of applicants', as well as the level of continuous financial distress reported by applicants, and select applicants based on those standards. Beyond this we cannot answer inquiries into the screening process.
3-4	By what amount specifically does "a significant decrease in part-time job income" mean?	We estimate a decrease in income of half or more. However, if the amount does not reach that much, it does not necessarily mean you are not eligible for the subsidy.
3-5	By what amount specifically does "a significant decrease in allowance due to a sudden change in family finances" mean?	We estimate a decrease in income of half or more. However, if the amount does not reach that much, it does not necessarily mean you are not eligible for the subsidy.

### 4. How to Apply (Application Form)

4-1	I cannot log in to the application system.	Please try inputting your login ID and password again.
4-2	I do not know the ID and password that I need to log in to the application system.	The ID is your student number. The password is your school e-mail address (before the @ symbol).
4-3	I would like to change the contents of my application. Can I apply again?	No, you cannot apply again. Applicants can only apply once.

4-4	I do not have my own bank account. Can I use my parents' bank account information?	Yes, you can use your parents' information. Only bank accounts registered to you or your parents or other guarantors can be used.
4-5	Is the phone number (phone number to be contacted in case of emergency) that I provide my own phone number or an emergency contacts' phone number? (I am still living abroad because I have not been able to go to Japan yet.)	Please input a phone number where we can get in contact with the student in question.
4-6	My allowance is not a set amount, and I did not receive any between April and June. Instead, I'm receiving several months worth in July. What should I do?	Please input an average monthly amount for the allowance.
4-7	What can be used as evidence of income or allowance?	Any cogent evidence that attests to the monetary amount.
4-8	I am a newly admitted student. Should I input the difference between my pay from when I was a high school student? (Because I just started university, I have not started a new parttime job, so should I input 0 yen as my current income?)	Please input one month's income from any month between July 2020 and March 2021. Input 0 yen as your amount of monthy income after your decrease/loss of income.
4-9	The guidelines ask for me to upload a scan of my bankbook. What pages should I submit?	<ol> <li>For income/allowance pre- and post-decrease</li> <li>The pages showing the income/allowance transferred to your account before and after your income decreased. In the scan you may black out all other details (other transfers, withdrawals, account balance, etc).</li> <li>For bank account information</li> <li>The pages showing the name of the bank, name of the account holder, and account number.</li> </ol>
4-10 (2021/7/15 Update)	I have input my information on my smart phone, but I cannot consolidate the documents of proof for my part-time job income and allowance into one attachment. What should I do?	If you can, please try and devise a way to consolidate all documents into one attachment, such as gathering the documents together and taking one picture containing all of them, or scanning them into one multi-paged PDF file.
4-11 (2021/7/16 Update)	The system is having issues and won't let me apply.  Ex: You filled out the entire application but the "submit application" button isn't working.  Ex:When seach and choose my financial instituitions on the item (28), my screen freezes.	You may get a system error and be unable to submit your application if your operating system and/or browser aren't up to date. If everything is up to date but you have this problem, try filling out the application in a different browser, or on a different computer, smart phone or tablet.

## 6. Applying as an International Student

6-1	Can I apply if I am currently being funded by the Japanese government?	Yes, you are eligible to apply. During the evaluation process, the fact that you are receiving such a scholarship will be taken into consideration.
6-2	I am an international student but I am not currently in Japan. Can I apply?	Yes, you are eligible to apply.
6-3	Can non-regular students, including exchange students apply?	This subsidy is for regularly enrolled undergraduate and graduate students. Unfortunately, you are not eligible to apply.
6-4	I am an international student, but I do not have a Japanese bank account. Can I apply?	Yes, you are eligible to apply. If selected, however, the subsidy will be transferred to you only after you come to Japan and open a Japanese bank account. Separate instructions will be sent to you on how to notify us of your bank account information. The subsidy will not be remitted abroad.
6-5	Can I apply for this support fund even if I am already receiving a scholarship from an outside institution (including JICA or JASSO)?	Yes, you are eligible to apply. During the evaluation process, the fact that you are receiving such a scholarship will be taken into consideration.
6-6	Can I apply if I am already receiving tuition reduction as an international student?	Yes, you are eligible to apply.

6-7	Should I input my middle name?	It is not necessary for you to input your middle name.
6-8	What should I input if I do not have a Japanese phone number?	Please input a phone number at which you can be contacted, even if it is not a Japanese phone number. If you are inputting an international number, please be sure to include the country code.
